Memorandum of Understanding (MoU)

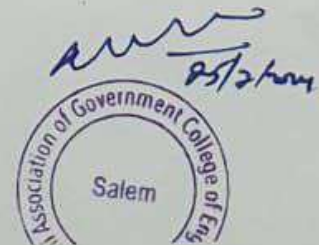

This Memorandum of Understanding (MoU) is entered on the 25th day July 2024 by and between Alumni Association of Government College of Engineering Salem Registered at Alumni Center Building, Salem Bangalore High Road, Government College of Engineering, Salem-636011 under Tamil Nadu Society Act 1975 with No: SRG/Salem West/68/2024 hereafter referred AAGCE SALEM-Society was established in 24th June 2024 and Government College of Engineering incorporated at Salem -Bangalore Highway, Salem-636011, was established in 1966 herein after referred to as "GCE SALEM".

Recitals

- AAGCESALEM-Society has registered to serve the Students, Alumni and the Faculties of Government College of Engineering Salem-11 under one forum for the dissemination and exchange of experience, knowledge and talents amongst its members and the students of the college and for the furtherance of fellowship, advancement of scientific knowledge in the general interest of the Community and the Country.
- GCE SALEM is a leading Institution of Technical Education offering various Under Graduate, Post Graduate and Doctoral programs in Engineering and Technology in Regular and Part time course.

- c. The purpose of this MoU is with reference to exploring the areas of cooperation, benefiting both the Collaborating institute and Faculties.
- d. GCE Salem has exhibited keen-interest in collaborating with AAGCE SALEM-Society for the mutual benefit of transferring, professional excellence, technical and scientific knowledge and to fulfill the society needs.

Now, in consideration of the mutual promises made herein, both GCE Salem and AAGCE SALEM-Society hereby agree to sign a Memorandum of Understanding (MoU) as follows:

Ref: Minutes of Meeting held on: 11.06.2024

Areas of cooperation:

GCE Salem Agrees to merge the existing unregistered Alumni Association run by Principal as Patron with AAGCE SALEM-Society with effect from 25th July 2024 onwards and here afterwards only one Alumni Association run by the society would be functioning in GCE premises.

The Outgoing Students from 2009 to 2024 studied in GCE Salem would be Ported and Merged with AAGCE SALEM-Society.

The Life Membership fees Rs 1000 per person Paid by the above out going students from 2009 to 2024 would be transferred to AAGCE SALEM-Society account, so as to become AAGCE SALEM -Society Valid and Approved Member.

In future, from 2025 onwards, the outgoing students would be paying directly their Life Membership Rs 1000 to AAGCE SALEM -Society account, so as to become as AAGCE SALEM-Society valid & Approved Members.

As per AAGCE SALEM -Registered Society No:SRG/Salem West/68/2024 By-law the Bank account would be Jointly Opened in any Nationalized Bank with PRINCIPAL cum PATRON of GCE Salem as one Authorized Signatory and President AAGCE SALEM -Society or the Treasure as the Co-Signatory.

GCE Salem has agreed, sanctioned & Permitted AAGCE SALEM- Society to have their Registered Office at Alumni Center Building, Government College of Engineering, Salem-11, to conduct any Events related to Alumni Activities, to Conduct AGM, Society Election inside the Premises of GCE Salem and also to Link & upload AAGCE SALEM- Society Website, Payment Gateway for Membership Payments and other fund raising, ONLY related to Alumni Activities as defined in the AAGCE Salem -Society.

This MOU shall be Effective from 25th July 2024 onwards or from the date of approval by Competent Authority from both ends and the duration of the MOU shall be Valid for a Period of NINETYNINE Years from the date of Execution.

Any clause of this MOU may be modified or amended as date required by mutually agreed between AAGCE SALEM-Society & GCE SALEM.

Governing Law: This MOU has been governed by the Laws of India Law in Chennai High Court. MoU can be renewed based on mutual convenience, shall have exclusive jurisdiction.

Termination: Either party can cancel or terminate unilaterally (and without reason) by giving an advance written notice of Three Months' time to other.
