6.2 There shall be Two categories of Members.


a) **Life Members:** Those who pay/paid a One-Time fee of Rs.1000/- (Rupees One Thousand Only) as Membership Fee.



Every Member shall have the following Rights and Duties in the association.


- a. Have one vote at Every General Body Meeting.

8.0 GENERAL BODY:


All the registered Members of the Association shall constitute the 'GENERAL BODY' of the Society.





- 8.4 The Association at its Annual General Body Meeting shall appoint each year any qualified and registered Chartered Accountant(s) to be the Auditors of the Association on such terms to the remuneration as may be fixed and approved by the Executive Committee of the Association.
- 8.5 The Executive Committee shall maintain or cause to be maintained proper accounts of the transactions and assets of the Association and the accounts shall be given in such form as may be directed by the Executive Committee in consultation with the Association's auditors.
- 8.6 The Executive Committee Shall Prepare and Place Audited Statements of Accounts, Receipts and Expenses of the year ending 31st March of that year in a form as may be directed by the Executive Committee, before the Association Every Year at the Annual General Body Meeting, in consultation with the auditor(s) together with the report of the Association's Auditor thereon.
- 8.7 In addition, the Executive Committee may convene other General Body Meetings, if necessary, herein after referred to as Extra-ordinary General Body Meetings (EGM).
- 8.8 If Twenty-Five or more members send a requisition to the President or to the Secretary in writing requesting them to convene an Extra-ordinary General Body Meeting to consider any important matter as they think necessary, the same should be considered by the Executive Committee and such Extra- ordinary General Body Meetings shall then be convened within Seven Days from the date of receipt of the requisition in writing and in accordance with the by-laws viz. 8.2.1, 8.2.2, 8.2.3, and 8.3.

8.9 Extra-ordinary General Body (EGM) by Special Resolution may Amend the Provisions of its Memorandum relating to the Objectives of the Association in so far as may be required to enable it.

- a) To carry on the Administration of the Association more economically and efficiently
- b) To Attain its Aims and Objects by new or improved means
- c) Amend existing By-laws or propose New By-law(s)

8.10 Any Special Resolution shall deem to have been passed only if not less than 3/4th of the Members present and entitled to vote in the meeting, approve the resolution.

8.11 An Amendment of the Memorandum of the By-laws shall take effect from the date of the passing of such Special Resolution.

8.12 An accidental delay in receipt of the notice by one or more members shall not render the meeting void.

8.13 The General Body Meetings shall be presided over by the President of the Association or in his absence by the Vice-President.

8.14 If the Vice-President is also not present then the Secretary or the Treasurer can Chair and Preside over the Meeting.

8.15 The quorum for the General Body Meeting shall be minimum 25 (Twenty-five) registered members.

8.16 If the minimum quorum of 25 (Twenty-five) members is not present at the General Body Meeting, the same meeting will be held after One Hour at the same venue. In such a postponed General Body Meeting, the minimum quorum will not be insisted.

8.17 Business to be transacted in Annual General Body Meetings:

8.17.1 To Elect all the requisite number of the Executive Committee (EC) members.





9.8 All the outgoing Executive Committee Members are **NOT ELIGIBLE** for re-election.


9.9 The Head of the Institution (Principal) of Government College of Engineering, Salem, shall be the **Patron** of the Association.

10.3.1 The Election Committee shall form a Schedule of Election through Ballot for nomination, last date of Receiving, Withdrawal of nominations and Date of elections and notify the Secretary of the Association.



11.0 POWER OF EXECUTIVE COMMITTEE(EC):

- 11.1 The Executive committee shall normally meet once in Three months.
- 11.2 The Secretary may, whenever he finds it necessary, call for an Emergency Meeting with the consent of the President or on the requisition of five members of the Executive Committee in writing.
- 11.3 Notices of all the meetings giving the Venue, Date and Time shall be sent by the Secretary to the registered address or through email, of the members with an Agenda for the meeting One week before the date of the meeting.
- 11.4 The minimum quorum for conducting the meeting shall be 2/3rd of the total strength of members of the Executive Committee.

- 11.6 In the event of the Vice President being not present or not being able to participate in the meeting, the Secretary or the Treasurer will Preside.
- 11.7 All questions arising at any meeting of the Executive Committee shall be decided by a majority of Members present and in case of equal votes, the Presiding Member shall have a Casting Vote.
- 11.8 No rule shall be Passed, Annulled or Modified except by a resolution supported by 2/3rd of the members in a General Body Meeting convened.
- 11.9 No rule or resolution of the Executive Committee shall be deemed to be invalid by reasons of such act or resolution having been done or passed during any vacancy in the Executive Committee.
- 11.10 No resolution passed by the Executive Committee at a meeting shall be brought up for reconsideration unless after the expiry of three months from the date of resolution, and unless fresh information likely to affect the decision was not available at the time of passing the original resolution, is placed before the Executive Committee for its reconsideration.
- 11.11 The Secretary shall ensure that the Minutes of Meetings (MoM) and or Approved Resolutions of any Meeting are duly signed by every Attendee and notify the EC and post them in Official Website well before the next Executive Committee Meeting.



12.0 Powers and Duties of the President:


13.3 The Secretary shall carry on all correspondence relating to the association and of the Executive Committee according to the resolutions and by-laws passed under these rules.





13.8 The Secretary shall maintain and submit to the Registrar of Societies all such records annual or other statements which are specified in the Tamil Nadu Registration of Societies Act and the Rules.





15.3 Earnings from Movable & Immovable properties/assets, if any.

15.4 Fund collected by the Association through any Cultural Programme, Exhibitions or any Function organized by the Association.

16. CORPUS FUND AND DONATIONS:





20.7 Activities within India:


No activities of the Society shall be carried out anywhere outside India. The Society should be confined within the territorial jurisdiction of India.





21.2 Approval:

22. SAVING CLAUSE:

The Association will have Perpetual Succession for all things not specifically provided in these Rules and Regulation, the provisions of the Tamil Nadu Societies Registration, the provisions of the Tamil Nadu Societies Registration act 1975 (Tamil Nadu Act no 27 of 1975) will apply.

23. ANNUAL LIST OF EXECUTIVE COMMITTEE MEMBERS (Section-4):

Once in a year a list of Office Bearers and Executive Members of the Executive Committee of SOCIETY/ASSOCIATION shall be filed with the office of the Registrar of Societies, as is required under section 4 of the Societies Registration Act, 1960(1860).
