PRINCIPAL

Rules Relating to the Grant of Condonation of Shortage of Attendance

- 1. A candidate who could Secure attendance (Full Time students is between 65% and 74% and Part Time Students is between 61 % and 69 %) only in the current semester due to medical reason i.e. Trauma/ Infectious Diseases / Surgeries requiring continuous medical attention, on submission of a valid medical certificate in time, obtained from a Government Doctor not below the rank of Assistant Surgeon are given exemption from the prescribed attendance requirement and he/she shall be permitted to appear for the current semester examinations.
- 2. A candidate who could Secure attendance (Full Time students is between 65% and 74% and Part Time Students is between 61 % and 69 %) only in the current semester or due to participation in College / University / State / National / International level Sports events, Paper or Project Presentation in National / International Conference with prior permission from the Principal shall be given exemption from the prescribed attendance requirement and he/she shall be permitted to appear for the current semester examinations.
- 3. Permission Mentioned in (1) and (2) can be allowed only **TWICE** during his /her entire course of study.
- 4. The Application should reach to COE office GCE/ SLM, ONE WEEK before the commencement of End Semester Examination.
- 5. The Condonation Fee is of (i) Rs.1000/- for First Time and (ii) Rs.5000/- for Second time should be paid in SBI, Omalur through the Chalan available at the COE office AFTER GETTING PRIOR PERMISSION FROM THE PRINCIPAL.
- 6. In case the shortage of attendance is beyond condonable limit such students will not be permitted to write the end-semester examination and are not permitted to go to next semester. They are required to repeat the incomplete semester in the next academic year after getting necessary permission from the authorities.
- 7. Applications which are not specifically recommended by the Head of the Department will not be entertained.
- 8. Head of the Department should not forward the applications for condonation of those students who have shortage of attendance beyond condonable limit.
- 9. Applications not conforming to the above rules will not be considered.
