- iii. Other elements of price such as duty / tax / Packing and Forwarding/loading and unloading/ installation should be included in addition to the basic price of the equipment.
- iv. All rates quoted should be in Indian Rupees (INR) only
- v. Price quoted by the bidder should be Firm and Final.
