





#### Disciplinary Committee

- In order to maintain discipline in the campus, it was decided to have proper dress code for students. It was decided that boys must avoid wearing jeans pants and girls must avoid leggings in the college campus.
- It is resolved to take action on students who sit or roam unnecessarily in the campus during out of office hrs and holidays. Disciplinary action will be taken on those students.
- If the students come late to the class, they should not be permitted inside the class.
- It is resolved that proper lighting is to be provided (by PWD - Electrical) in the pathway to hostel.
- Security personnel to be asked to warn students who roam in the campus during night times.
- It is understood that senior students give Assignments and Record note books to juniors for writing. Severe action will be taken against those senior students.



**RULES AND REGULATIONS FOR STUDENTS**

1. Exchange of greetings with the members of the staff in the college and hostel by saying “Vanakkam” or “Good Morning / afternoon / evening” is encouraged.
2. A minimum of 75% of attendance in subjects, tour and camps will be insisted upon for each semester individually.
3. Students must be punctual for each period.
4. Attendance for the college examination is compulsory and leave or absence from the examination will be permitted only on valid reasons.
5. Students should maintain good progress and conduct which are prerequisites for appearing for the University Examination.
6. Students should avail leave only with the prior permission from the Faculty Advisor. When leave is availed for unforeseen causes, a leave application must be submitted soon after the availing of the leave. Such application will be considered only on the production of a Medical Certificate from the College Doctor, or the applicant should produce evidence of the unforeseen cause. No student should write an application for leave on behalf of another student. Students who avail leave should furnish their address to the Principal and the Deputy Warden.
7. In case of serious illness and infectious diseases, students should report to the concerned Deputy Warden and the College Medical Officer for necessary action.
8. All male students are expected to wear pants and shirts neatly tucked in or bush shirts. The dress must be clean. Female students are expected to wear chudidhar with dupattas. Half sarees, skirts and frocks are not permitted. In the workshop, male students shall wear only shirts and trousers. Chappals worn in the workshop or in field work must be securely strapped at the heel. Female students will have to wear pants, shirts and shoes for the practical classes in the workshop, and for other laboratory classes they will have to wear overcoats. While playing games, shorts and vests or jerseys must be worn by male students.
9. Students will have to pay for breakage or losses in the laboratories and workshop.
10. Students should equip themselves with approved instrument boxes, text books, record note books and sheets, field books and note books which can be purchased from the Students’ Co-operative stores or any other bookshop.
11. Usage of cellphones during the class hours is strictly prohibited. If found cellphones will be confiscated.

**Subject: Regarding Anti Ragging Day decided to be observed on 12<sup>th</sup> August, 2023 followed by Anti Ragging Week from 12<sup>th</sup> August to 18<sup>th</sup> August, 2023.**

In order to prevent ragging All India Council for Technical Education (AICTE) has framed All India Council for Technical Education (Prevention and Prohibition of Ragging in Technical Institution, Universities including Deemed to be Universities imparting technical education) Regulations, 2009. These Regulations are mandatory and all AICTE approved Institutions/universities are required to take necessary steps for its implementation in toto including the monitoring mechanism as per provisions prescribed in the above Regulations and ensure its strict compliance.

As a step further, it has been decided that from this year Anti Ragging Day would be observed on 12<sup>th</sup> August followed by Anti Ragging Week from 12<sup>th</sup> August to 18<sup>th</sup> August. This initiative is one of the tools of the Council in increasing awareness against ragging. It is further desired to adopt the following activities during the celebration of Anti Ragging Day/Week:

- i. Introduction Orientation Programme on Anti Ragging.
- ii. Conduct various competitions such as slogan & essay writing, poster making, and logo designing on Anti Ragging and distribute certificates/prizes to encourage the students/faculty/non-teaching staff to promote Anti Ragging.
- iii. Events like Anti-Ragging workshops, seminars and other creative avenues to spread the idea.
- iv. TVCs short films and documentary movies may be shown to students and faculty. (Available on UGC website i.e. [www.ugc.ac.in](http://www.ugc.ac.in) & [www.antiragging.in](http://www.antiragging.in)).
