Terms and conditions for the appointment of surplus teaching staff of Annamalai University in Government Colleges of Engineering on agreement basis.

- The tenure of appointment of surplus teaching staff of Annamalai University as Assistant Professor in Government Colleges of Engineering on agreement basis will be for a period of 3 years from the date of joining in the respective colleges.
- The surplus teaching staff of Annamalai University to be appointed in Government Colleges of Engineering shall have the qualifications for the post of Assistant Professor as prescribed in the Service Rules of Technical Education Department.
- They shall submit a physical fitness certificate obtained from the registered medical practitioner at the time of joining in the College.
- During the period of agreement, the surplus teaching staff are entitled to receive their pay and other allowances in the pay band applicable to the post of Assistant Professor in Government Colleges of Engineering with pay protection.
- The Government have rights to appoint the surplus teaching staff of Annamalai University, in any of the Government Colleges of Engineering wherever the vacancy exists.
- The Principals of Government Colleges of Engineering shall verify the certificates of educational qualifications of teaching staff of Annamalai University before allowing them to join the College.
- The pension and leave salary contribution and also employer's contribution to the CPS for the surplus teaching staff of Annamalai University (who had been appointed after 1.4.2003) during the agreement period shall be borne by the Government.

- The surplus teaching staff appointed shall not be regarded as the member of the service in which he / she has been appointed and shall not be entitled to any preferential claim on such appointment.
- In respect of any other matter, for which no provision has been made in the terms and conditions, the decision of the Government is final.
- The Government have the rights to take disciplinary action against the surplus teaching staff of Annamalai University for irregularities or lapses committed by them during their agreement period.
- They are eligible for 12 days casual leave per year as applicable to the Government servants during the period of their agreement.
- The surplus teaching staff of Annamalai University appointed under this agreement shall not indulge in any activities detrimental to the Government interest.
- During the agreement period the surplus teaching staff should not request for termination of agreement and reversion back to Annamalai University.
- After the completion of tenure, they shall be reverted back to the Annamalai University.
- The period of service rendered in Government Colleges of Engineering by the surplus teaching staff of Annamalai University on agreement basis shall be counted for service benefits.

- The tenure of appointment of Thiru as Assistant Professor / in Government Engineering Colleges on agreement basis will be for a period of 3 years from the date of joining in the respective Government Engineering Colleges.
- The employee shall have the qualifications prescribed for the Assistant Professor post, as per the Service Rules of Technical Education Department.
- The employee shall submit a physical fitness certificate obtained from the registered medical practitioner at the time of joining in the Government Engineering Colleges.
- During the period of agreement, the employee is entitled to receive his / her pay and other allowances in the pay band applicable to the post of Assistant Professor in Government Engineering Colleges with pay protection.
- The Government have the rights to appoint the surplus teaching staff of Annamalai University in any of the Government Engineering Colleges, where ever the vacancy exists.
- The pension and leave salary contribution and also employer's contribution to the CPS for the surplus non - teaching staff of Annamalai University (who had been appointed after 1.4.2003) during the agreement period shall be borne by the Government.
- The employee appointed shall not be regarded as the member of the service in which he / she has been appointed and shall not be entitled to any preferential claim on such appointment.

- In respect of any matter for which no provision has been made in the terms and conditions, the decision of the Government is final.
- The Government have the rights to take disciplinary action against the employee for irregularities or lapses committed by them, during their agreement period.
