6.2.2 Institution implements e-governance in its operations.

6.2.2.1 e-governance is implemented covering the following areas of operations:

Administration:

- Student certificate verification is conducted online.
- Institute and hostel fees are paid electronically.
- Grievances from both faculty and students are received via email through the grievance redressal committee.

Finance and Accounts:

- Expenses are covered by block grant funds as a Government Autonomous Institution.
- All financial transactions are carried out digitally.
- Purchases are made exclusively through e-procurement portals such as the state Government e-portal, GEM portal, and ELCOT.
- Account-related documents are stored in electronic format.
- Government Provident Fund (GPF) and Contributory Pension Scheme (CPS) amounts for staff members are credited online.

Student Admission and Support:

- Student admission process is carried on by TNEA every year using their dedicated software.
- Gathering of student data, registration of courses, and their entry into the Examination Management System
- Students' Scholarship is maintained using National Scholarship portal.
- Students have access to current and previous regulations for their academic activities in web site.
- Essential forms for students, including Bonafide certificate requests, No dues formats, and Discontinuation request forms, are accessible on the college website.
- Regular updates and announcements for students are posted on the website.
- The digital records of attendance and CIA marks are subsequently transferred to the result processing system for further action.

Examination:
